Dear all and NCAT

DONT murder me

I have no doctor transport working phone help healthcare human or legal rights been hospitalised ten times died once and I'm pushed to the edge today by YOU

I write to you with grave urgency regarding my immediate safety and well-being. This morning, I was falsely accused of pedophilia by a voice implanted in my head through V2K harassment, a form of psychological warfare used against me for years. This baseless accusation is part of a broader campaign of surveillance, intimidation, and harassment designed to discredit and destroy me.

The notion that such a false accusation never tested in court justifies withholding help is absurd and wrong, and I demand that this injustice be rectified immediately.

The authorities, including the police, are complicit in this, and they have been protecting individuals like Stefan Iasonidis while allowing false evidence to be planted to justify their actions.

I have left my house, fearing that corrupt police or the CAT team will arrive to intimidate or harm me based on this false evidence. I cannot remain in this dangerous environment, where I am constantly under surveillance and harassment. The ongoing V2K attacks, combined with the systemic neglect and abuse I've endured, have pushed me to the brink.

If I die, the government will be fully responsible for my death, which will amount to murder and a targeted assassination.

My appeal to the OHCHR has failed, further demonstrating how **society has deliberately failed me**, despite my lifelong contributions. **I did not fail society—society failed me.** I have been denied access to basic human rights, medical care, and financial support, and my situation has been ignored or dismissed at every level. The voices in my head are now falsely accusing me of the most heinous crimes as a means to justify this ongoing persecution, which is utterly absurd and cruel.

I demand that NCAT immediately grant me **guardianship**, as I am unable to secure the basic necessities of life due to systemic failures and psychological abuse. Without this guardianship, I have no legal advocate to protect me from further harm, and I will continue to be victimized by the very authorities that are supposed to serve and protect me.

I demand the following immediate actions:

1. **Grant me Guardianship**: NCAT must appoint a guardian to ensure my legal, financial, and medical rights are protected. Without this, I am at immediate risk of further harm or death, and I will have no protection against the corrupt forces working against me.
2. **Immediate Legal Representation**: I require a lawyer to advocate for my rights and hold those responsible for my targeted persecution accountable.
3. **Access to Basic Necessities**: I urgently need hot food, medicine, medical care, and shelter for both myself and my sick dog, who is also in need of veterinary care.
4. **Protection from Ongoing Psychological Abuse**: The V2K harassment and other forms of surveillance and intimidation must be stopped immediately. This is a clear violation of my human rights and cannot continue unchecked.
5. **Immediate Compensation and Support from VOCAT**: VOCAT has acknowledged me as a victim of

crime, and any further delays in compensation will directly contribute to my deteriorating condition and imminent death.

Additionally, I am enclosing evidence of government contractor surveillance and intimidation from 2022, as well as corroboration from Grace, an NDIS worker, who confirms that voices and people were sent to harass and intimidate me. These are clear examples of the systemic corruption and conspiracy that I have been subjected to, and I demand that NCAT acknowledge the urgency of my case and take immediate action.

I cannot endure this any longer. **If immediate steps are not taken, my death will be the direct result of government negligence and abuse**, and the government will bear full responsibility for my murder.
This is your final opportunity to intervene before it is too late.
