The basics:

I suffered a 'lethal' injury at weribbee mercy hospital

It was covered up by HCC

It was covered up by MHCC

It was seen as nothing to investigate by the Victorian Ombudsman ben Calder

corruption

The suicide could be seen as a conspiracy to manslaughter.

This is because I suffered systemic oppression from many agencies

corruption

The issue concerned an innocuous recording of a GP - in which Mr Ball his lawyer framed me as an extortionist

corruption cover up

I had no idea until after my suicide/murder in Weribbee mercy Hospital

The complaint was largely unbalanced inequitable and unfair in the process; every institution or organisation had a lawyer or litigation team, and I had none.

discrimination corruption

I was rejected from the MHCC and the MHLC

The 'recording' should have been heard in a court to expose the malpractice and negligence.

I have nothing against the Dr but when I saw my suicide note after my friend suicided and I had moved I decided to act

Records will show I tried to protect the GP and just wanted an acknowledgement of the issue and a token conciliation-but it was covered up systemically by many agencies and I was framed

Issue 2:: Former partner Steve Iasonidis

I was engaged to Steve Iasonidis for 5 + years.  
He left me with no formal separation, but he did gift me his car, then stole it off me.

Corrupt ASIO official  
Coercion by public official in personal life  
Threatened a hit man  
Deceptively escaped with over a million in super and assets  
Blackmailed me

He left me with his dying dog

He was an employee of ASIO and was caught investing 1.2 million in an offshore tax haven that he made from the sale of a house in Abbotsford that he earned by dealing cocaine.

He was caught and let off with a fine. I wonder if his threat of ruining me holds true

I have tried in vain to get a conciliation but have been threatened by hit men and I was told by him I was ruined.

I still want a separation with an unbiased lawyer for settlement of assets and him to prepare a statement of his assets at the time of our breakup to settle the dispute

I have told police they did not act  
corruption

I spent my nest egg on him - and he earned upwards of 200000 per year. The relationship was based on coercion sexual slavery and he had me tricked into believing he cared.

I told police about the sexual slavery and financial control

corruption

He left me homeless, and took off with over a million in super and much more in assets

Her blackmailed me by saying I would go to jail for accessing a DSP (which he told me to do), or he implied he could have me beaten up or killed.

corruption of a public official

I want a lawyer for that separation to happen

Other issues

VOCAT 1

I was savagely beaten and hospitalised in an affray at The Dancing Dog in Footscray where I came to the aid of another person I thought would be killed

I made a complaint with VOCAT however somehow, even though I was the one who stayed and did the Police report, I was identified as the principal aggressor.

I did not understand why, it was because I was framed

corruption

VOCAT 2

I became aware of childhood sexual abuse late in life, whilst I was studying my PhD.

I was living in Ocean Grove after my suicide attempt before I made the complaint about Dr Whittaker, in which I was framed.

I made a report to police, and it went down the line until I got a VOCAT lawyer [www.yourlawyer.com.au](http://www.yourlawyer.com.au)

I think the word on the street was that I was an extortionist - and I was doing this for money. I am appalled.

The case was extremely distressing. It took five different lawyers and nearly

three years for the decision to come before Geelong Magistrate court.

The lawyer told me verbally on the phone it fell over, yet never gave an outcome.

illegal

I protested this, but got nowhere

Corruption

After the time for an appeal had passed I had begged the magistrate for why?

She wrote to me and said I was 'doomed to fail from the start.'

I did not understand why she would have said this.

I believe it is because I have been framed and black listed systemically with intent to maim me financially and destroy me  
conspiracy to pervert the couture of justice

### **ITS NOT MONEY**

I have been framed as an extortionist I know that now. I read what Dr Whitakers lawyer said in the FOI from AHPRA after I was released from hospital with no food no job no car and squatting

abuse of public trust and rejection of duty of care

I have been systemically oppressed and denied a voice - anywhere

conspiracy to pervert the course of justice  
victimisation

In (date) about the time of the Whitaker case, I was gifted \$100k by my former landlord, apparently for my advocacy work.

Here is a screen snapshot:

He told me it was a mistake because he was on drugs and had been hospitalised and voices told him to do it.

So - I gave it all back. That is an example of my ethics.

I am a registered therapeutic support for the NDIS under contract for the NDIA

I am a Government employee for insurance purposes, but work safe refused to assist in my appeal to Comcare the national insurance agency and work cover people, where I would receive compensation.

Paul Fowler rejected my claim after extending my suffering in destitution - he was the old boss at work safe.

Now my case is before the AAT, however as I have researched the other places that have aided and abetted my financial distress AFCA are under Michaelia Cash's portfolio and I have already called the attorney general's office who oversee Michaelia Cash's portfolio

They refuse to speak with me.

I know my AAT case will be corrupted.

The AAT emailed me to say they have a lawyer to represent them - I don't have a single person in my life, a friend, a carer, or a dr.

I worked with a man who had serious child sexual assault issues including incest and rape for over a year and a half.

Such was his mental illness, I collated his story which he could only manage in bits and pieces and summarised it for his VOCAT case.

Because I had been systemically oppressed and was paranoid about why my VOCAT cases were not successful, I became paranoid I was framed and set up.

When the magistrate finally sent me my audio recording of the court hearing, which I never listened to, I could not go back to work, as I saw this client 3-5 times a week.

## **HCF**

My injury was work related and later in hospital, it would be described as 'adjustment disorder'.

Not 'psychosis' nor 'delusions of persecution', but a sane reaction to actual

stressors.

HCF denied my claim and have banned me from contacting them.

They owe me nearly \$75000 yet they say my injury was pre existing

### **AFCA**

I had cases with AFCA that were overdue for determinations, and had a sum worth of over a million dollars.

They acted in congruity with HCF in that they delayed any outcome until I was bereft of prosperity and my financial stressors were aggravated.

## **HOSPITAL**

I had been systemically oppressed for so long, and forced into destitution - that I published on my website I would kill myself on 2nd April unless someone stood up for me in all these litigation cases. Not one person did. Not one person in the world.

I recorded the takedown of police who hated me and of salt water clinic and Cat team staff who took me to hospital and I was absolutely fine at home having a drink

I saw Dr Kumar 12 years beforehand and he rejected me medication I needed to I did not see him again. He knew of my partner Steve Iasonidis and the troublesome relationship it was and recommended I call police at the time.

Dr Kumar was the head at the hospital who was overseeing my care, and he absolutely knew of the ASIO link

The exit notes after my suicide considered I was neither 'psychotic' nor 'delusional' and it was a sane reaction to stress and stressors.

- and in this way it validated the movement to silence evidence and oppress

me systemically - which the hospital were now guilty of as well as a wrong diagnosis and malpractice and the fact I had suffered a 'fatal' injury in their hospital.

### **After hospital**

#### **Centrelink**

Centrelink refused to acknowledge the situation that I had survived killing myself OR that I had been on a DSP before for over a decade.

They put me on Jobseeker - and I was expected to find work even though I had been systemically oppressed and innocuously threatened to kill myself but I had unknowingly been framed and then I did kill myself with an agreed illegal contraband yet I was still squatting and recovering from the suicide and I was in greater distress than ever before

#### **Salt water Clinic**

Salt water clinic was a mental health unit I was released to after hospital for follow up care.

I had no psychiatrist

conspiracy and framed and victimised  
malpractice

I was denied my medication and my psychiatrist abandoned me - accusing me of fraud.

I saw a psychiatrist at salt water clinic only twice in about ten months.

This is more than a bad public mental health system. This is a conscious and malicious way of extending my suffering in the hope I would kill myself before justice.

The second time was to kick me off the books officially exonerating me from the system.

The boss of that clinic was Mr Stevenson.  
He was also the head at weribbee hospostal where I was murdered, for want of a better word.

## **MY COMPLAINT ABOUT HOSPITAL SUICIDE / MURDER**

The following organisations rejected my complaint of actually suffering a 'Lethal injury' in a hospital where I was supposed to be to avoid that.

The HCC.

THE HCC

The MHCC - the person was a double agent and a lawyer for the hospital  
The office of the information Commissioner  
The MHLC banned me  
The MHCC also banned me - begged many other agencies

So I went to the victorian ombudsman

Ben Calder the ombudsman saw no issue and threw it out

risk to health and misdiagnosis  
conspiracy and I was framed  
discrimination  
victimisation in the hope I would die  
systemic corruption

Dr stevenson was so thrilled of how impervious he was to do with law and my framing that I could not access any litigation was bereft of finance and had been left to die - that he asked me to sue him personally and directly for the killing.

The audacity that showed was reflected in the 'apology' that the ombudsman said was enough. When I tried severing my artery I looked for something sharp - I had snapped a toilet brush in half.

The hospital to my ire packed it and returned it to me in my bag when I was in intensive care.

The apology came from (name) who did not apologise for all the wrongs of the hospital but by saying sorry because 'it is not hospital policy to give away our property' - regarding the broken dirty toilet brush.

They know they are untouchable and can act with impunity

### **Micron21 deleting all my evidence**

Without warning, micron21 who hosted my emails and website (which was also my ABN and my business I had hoped to go back to) deleted in an intentional and amalicious way

All my data  
All my emails  
All my evidence  
All my years of struggle  
They knew it was a court case  
They knew it was my ID

They knew it was my IP  
They knew I was in hospital

They accused me of being 'conspiratorial'.

To this day, they are in control of my website.

They pointedly went out of their way to delete all my evidence  
This I believe was because the movement wanted to further desecrate me

They wanted to destroy my evidence and were told from a higher authority  
they would have immunity from the law.

**I complained to relevant agencies**

my ABN ...(which I have built over two decades),

I complained to [business.vic.gov.au](http://business.vic.gov.au)  
They refused me

**They told me to go to the small business and family ombudsman - I did

**I went to the telecommunication industry ombudsman and they rejected  
me too**

**I have been everywhere**

**I can't get a lawyer**

**I have told police many times**

**I am framed.**

**The police keep hassling me and people are sent to my home and general  
area to scream abuse at me exploiting my paranoia**

**I have been to police many times to no avail for any of this  
They told me the homicide squad is investigating my near death  
experience at weribbee mercy - then kicked me out  
Later a senior officer rejected this  
I tried to report crime many times to them**

**I have been banned from AFP and and I have been banned \from crime  
stoppers**

**Crimestoppers sent the police to my door whilst I was on the phone to**

him

and I was incarcerated because I became ill from work, and was refused

Judi the police are surrounding me
