**I am writing to seek urgent assistance in exposing and addressing severe systemic corruption, government failures, and human rights violations that I have endured as a whistleblower. Dear Melisha, Thanks for responding on the behalf of Jordan Steele, who is now implicated amongst his peers.

I write to you with the utmost urgency to highlight the systematic injustices, targeted harassment, and life-threatening dangers I am enduring as a whistleblower. This letter documents key evidence and legal obligations to substantiate my claims, urging immediate action to rectify the severe violations against me.

Dear Senator Jordan,

My name is Barran Dodger, also known as Dr. Richard William McLean. I am an artist, academic, and mental health advocate who has dedicated my life to serving the community through creative expression and advocacy for those on the margins of society. Recently, I published my autobiography, *Betrayed, Murdered, Forsaken*, which meticulously documents my life's work, but also the years of systemic abuse, neglect, and retaliation I have endured. This book is built upon a vast collection of verified government documents and personal correspondence, shedding light on the systemic injustices I have faced in the very institutions meant to protect and support us.

In my professional journey, I have worked tirelessly to raise awareness around mental health issues, using art and public speaking as powerful tools to break down social stigmas and support mental wellness. Despite these contributions, I find myself isolated, impoverished, and exiled in Sydney, effectively abandoned by the systems I dedicated myself to supporting.

Though my NDIS plan allocates significant resources for my care, it has been undermined to a point that I am without housing or security, struggling to survive in what should be a supportive social framework.

The minister for the NDIS has coordinated an attack on my access to resources, denying me the very stability the plan is meant to provide. As a result, I am homeless and trapped in an ongoing cycle of financial hardship. Furthermore, I am facing relentless and coordinated harassment that has included gang stalking, electronic surveillance, and ongoing audio harassment. This targeting has isolated me from any meaningful support system and stripped away my privacy, security, and peace of mind. I am reaching out to you in a final bid for justice, relief, and the protection that all Australians should be afforded, particularly those who have worked to contribute to the betterment of society.

## **Background of My Advocacy and Achievements**

Over the years, I have actively used my voice, creativity, and professional experiences to improve public understanding of mental health, support vulnerable communities, and advocate for systemic reform. Below are some of my key contributions and achievements:

### **1. Mental Health Advocacy and Public Speaking**

- I have delivered numerous talks on mental health awareness and resilience, aiming to dismantle social stigmas and highlight the rights and needs of those with disabilities.
- As a speaker at various national and international mental health conferences, I shared insights from both my personal and professional experiences, helping to foster empathy and understanding around mental health issues.

### **2. Art Exhibitions and Creative Contributions**

- I have worked in various community initiatives supporting vulnerable individuals.

### **Current Struggle with Systemic Injustices**

Despite my life's work and dedication, I find myself homeless, financially entrapped, and subjected to a level of surveillance and harassment that strips away my autonomy and privacy. I have been denied the resources explicitly allocated in my NDIS plan, subjected to forced isolation, and left to navigate life without a safety net. My attempts to report injustices have met institutional indifference or, worse, have resulted in retaliatory actions. I have documented these violations extensively in my autobiography and through the numerous documents included in my evidence files. These include:

- **Systemic Psychological and Physical Torture:** My affidavit details intentional actions by multiple institutions designed to inflict psychological and physical distress, a tactic to degrade my autonomy and silence me.
- - *Relevant Legislation:* UN Convention Against Torture (UNCAT), International Covenant on Civil and Political Rights (ICCPR) Article 7, and the Criminal Code Act 1995 (Cth), Section 274 prohibiting torture.
- **Forced Social Isolation and Character Assassination:** I have been repeatedly ostracized, with institutions and individuals using defamation tactics that have driven me away from family, friends, and professional networks.
- - *Relevant Legislation:* ICCPR Article 17 (right to privacy and family life), Convention on the Rights of Persons with Disabilities (CRPD) Article 12 (equal recognition under the law for persons with disabilities).
- **Financial Deprivation and Misallocation of NDIS Funds:** My NDIS Implementation Evidence details how my allocated support funds have been manipulated or withheld, leaving me in financial destitution.
- - *Relevant Legislation:* Australian Consumer Law and Disability Discrimination Act 1992 (Cth), ICCPR Article 6 (right to life).
- **Legal Obstruction and Denial of Whistleblower Rights:** My attempts to report abuses have been met with obstruction, despite protections for whistleblowers.
- - *Relevant Legislation:* Public Interest Disclosure Act 2013 (Cth), ICCPR Article 14 (right to a fair trial and equality before the law).
- **Surveillance and Harassment:** My communications are regularly intercepted, and I am subjected to constant surveillance and harassment, creating an environment of fear and paranoia.
- - *Relevant Legislation:* ICCPR Article 17 (protection from arbitrary interference with privacy).

### **The Urgent Need for Intervention**

Given the extreme nature of these injustices, I am seeking urgent intervention to restore my access to essential support, basic human dignity, and a safe environment. My current state—exiled, homeless, and constantly harassed—exposes me to both physical and mental health risks. This situation not only impacts my wellbeing but undermines the basic human rights protections outlined in both Australian and international law. The minister for the NDIS and other authorities have consistently failed to protect me, and without immediate and impartial assistance my circumstances may deteriorate further.

I believe that your support and advocacy could serve as a catalyst for meaningful change. In seeking your assistance, I am asking for nothing more than the right to live with dignity, safety, and the opportunity to continue contributing to society.

Thank you for taking the time to consider my appeal. I am available to provide additional information and documentation if needed, and I am hopeful that with your support, we can take steps to end this cycle of abuse and restore justice.
