### **3. Access to Basic Resources**

- Reinstate my disability pension and ensure I have access to food, medical care, and financial stability.**

### **4. Independent Investigation**

- Launch inquiries into the misconduct of NDIS providers, public guardians, and government officials complicit in my targeting and exploitation.**



## **5. Accountability for Threats and Neglect**

- Report the threats against my life to law enforcement and ensure immediate protective measures.**

### **The Consequences of Inaction**

**Ignoring this message will serve as undeniable evidence of your complicity in my destruction. Inaction will implicate you in:**

- 1. Sustaining Corruption: By ignoring evidence, you protect those profiting from fraud and exploitation.**
